## Plan Summary [2024-25]

### General Information

A description of the LEA, its schools, and its students in grades transitional kindergarten–12, as applicable to the LEA.

Gateway International School (GIS) is operated and overseen by Gateway Community Charters (GCC), a 501c3 non-profit charter management organization (CMO). The school is governed pursuant to the bylaws adopted by the incorporators, as subsequently amended pursuant to the bylaws. GCC have been operating since 2003 and have expanded to serve over 5,800 students and 750 employees across nine charter schools. GCC charter schools serve predominantly underserved, vulnerable and at risk students; including English Learners, socioeconomically disadvantaged, 5th year seniors, foster and homeless. Gateway Community Charters manages a complex budget and has maintained above the required 3% reserve for each of its charter schools as well as keeping an additional reserve as needed for facilities, cash flow, and additional budget sustainability all while expanding enrollment.

The GCC Board of Directors believes that learning best occurs when students are provided with an educational program that challenges and motivates everyone to achieve their full potential. GIS is an independent charter school serving 598 students as of April 2024 in grades TK-8th in the Arden-Arcade area of Sacramento county. The school is in its 11th year of operation having been authorized in April 2013 by San Juan Unified School District. GIS serves a large English learner population (55.55%) and also serve a large population of students who are socioeconomically disadvantaged (75.5%). In order to better serve the students and their families, GIS have put time and effort into building relationships with our students through the Capturing Kids’ Hearts Program, social-emotional learning lessons through Sami’s Circuit and Ripple Effect, and a focus on PBIS.

GIS was authorized as an International Baccalaureate (IB) World School for the Primary Years Program (PYP) for TK-5th in the spring of 2016, and the Middle Years Program (MYP) for 6th-8th in the spring of 2018. Each program has gone through one successful evaluation visit: PYP in 2020 and MYP in 2023. GIS uses board approved curriculum that are aligned to Common Core and Next Generation State standards for core subjects. PYP uses standards based report cards and MYP uses the traditional report cards along with IB report cards. Other programs that have a direct impact on student culture and social connections include Music, Art, Project Lead the Way, Russian and Spanish Instruction, Associate Student Body (ASB), After-School Program (ASP), and ASP clubs. These offerings play a critical role in the development of our students’ ability to be creative and function in the IB program. These programs are a strong element that aid in setting GIS school community apart from many other public schools in the area.

GIS expanded its after-school program to serve 396 students for the 2023-24 SY. This was possible with the Expanded Learning Opportunity Program (ELOP) funding and additional staffing. GIS added clubs within its program and utilizes outside vendors to bring additional clubs to engage students in the extended day. Such clubs include tap and ballet, sewing, knitting, chess, checkers, Lego Robotics, eSports, seasonal supports, choir, clay art, Girl Scouts, Heart and Soul, Girls on the Run, painting, and photography to name some. To close the achievement gap, tutoring with certificated staff is offered to all low-achieving students during the after-school program. Additionally, GIS offers online tutoring in Math to students approaching grade level standards and students exceeding grade level standards.

The El Dorado Charter SELPA supports GIS in meeting the needs of students with disabilities by providing professional learning to staff and administrators, Alternative Dispute Resolution tools and assistance, facilitation of root cause analysis for Program Indicator Review and other Special Education accountability measures, and access to program specialists and other technical experts to assist with specific student needs.

GIS has 91 employees; 35 certificated and 56 classified. Certificated staff consists of the Principal, two Vice Principals, an Instructional Coach, School Counselor, RSP Specialist, part-time Speech Therapist, part-time School Psychologist, and 30 highly qualified teachers. The classified staff consists of office personnel, Site Manager, ASP Supervisor, Parent Liaison, custodians, para-educators, and playground assistants. There are 13 males and 78 females on staff. Thirty-nine staff members are bilingual in Russian and/or Ukrainian, five are bilingual in Spanish, one in Fijian, two in Punjabi and Hindi, and one staff for each of these languages: Turkish, Hmong, Farsi, and ASL. Some of the staff are fluent in three languages.

## Reflections: Annual Performance

A reflection on annual performance based on a review of the California School Dashboard (Dashboard) and local data.

Enrollment at GIS has reached an all-time high, largely driven by newcomers following the Russian/Ukrainian war. Despite this influx, the school has shown consistent improvement in student performance on i-Ready assessments, though there has been a slight decline in CAASPP scores since the onset of the pandemic. The surge in enrollment, combined with pandemic-induced educational disparities, has led to notable shifts in measurable data. Notably, i-Ready data has emerged as a reliable predictor of CAASPP outcomes, guiding GIS's efforts to prepare students for state-mandated assessments. Analysis of the 2022-23 CA Dashboard data indicates a decline in both suspension rates and chronic absenteeism at GIS. While English Language Arts (ELA) data remains in the green, Math data has shifted to the yellow category. The English Learner progress is also marked as yellow, possibly due to the influx of newcomers. GIS remains committed to prioritizing student outcomes and will continue implementing targeted interventions to support learning.

Regarding the CA Dashboard, GIS was classified as needing Additional Targeted Support and Improvement (ATSI) for absenteeism and suspension among Hispanic and socioeconomically disadvantaged (SED) subgroup students in 2021-22. However, with the latest dashboard data, GIS has exited the ATSI status, showing improvements for both subgroups in 2022-23. Overall, GIS has transitioned from a very high classification to yellow across all metrics, with notable improvements in suspension rates for both Hispanic and SED subgroups. Suspension rates for Hispanic students have shifted from very high to orange, while those for SED students have improved from very high to green. These changes reflect GIS's ongoing efforts to address disparities and ensure a supportive learning environment for all students.

## Introduction and Instructions

The Local Control Funding Formula (LCFF) requires local educational agencies (LEAs) to engage their local educational partners in an annual planning process to evaluate their progress within eight state priority areas encompassing all statutory metrics (COEs have 10 state priorities). LEAs document the results of this planning process in the LCAP using the template adopted by the State Board of Education.

The LCAP development process serves three distinct, but related functions:

- **Comprehensive Strategic Planning:** The process of developing and annually updating the LCAP supports comprehensive strategic planning, particularly to address and reduce disparities in opportunities and outcomes between student groups indicated by the California School Dashboard (California *Education Code* [EC] Section 52064[e][1]). Strategic planning that is comprehensive connects budgetary decisions to teaching and learning performance data. LEAs should continually evaluate the hard choices they make about the use of limited resources to meet student and community needs to ensure opportunities and outcomes are improved for all students.
- **Meaningful Engagement of Educational Partners:** The LCAP development process should result in an LCAP that reflects decisions made through meaningful engagement (EC Section 52064[e][1]). Local educational partners possess valuable perspectives and insights about an LEA's programs and services. Effective strategic planning will incorporate these perspectives and insights in order to identify potential goals and actions to be included in the LCAP.

- Annually reviewing and updating the LCAP to reflect progress toward the goals (*EC* Section 52064[b][7]).
- Ensuring that all increases attributable to supplemental and concentration grant calculations, including concentration grant add-on funding and/or LCFF carryover, are reflected in the LCAP (*EC* sections 52064[b][6], [8], and [11]).

The LCAP template, like each LEA's final adopted LCAP, is a document, not a process. LEAs must use the template to memorialize the outcome of their LCAP development process, which must: (a) reflect comprehensive strategic planning, particularly to address and reduce disparities in opportunities and outcomes between student groups indicated by the California School Dashboard (Dashboard), (b) through meaningful engagement with educational partners that (c) meets legal requirements, as reflected in the final adopted LCAP. - **10. Total Percentage to Increase or Improve Services for the Current School Year:** This percentage will not be entered. The percentage is calculated based on the amounts of the Estimated Actual LCFF Base Grant (9) and the Estimated Actual LCFF Supplemental and/or Concentration Grants (6), pursuant to 5 CCR Section 15496(a)(8), plus the LCFF Carryover – Percentage from the prior year. This is the percentage by which services for unduplicated pupils must be increased or improved as compared to the services provided to all students in the current LCAP year.

## Calculations in the Action Tables

To reduce the duplication of effort of LEAs, the Action Tables include functionality such as pre-population of fields and cells based on the information provided in the Data Entry Table, the Annual Update Summary Table, and the Contributing Actions Table. For transparency, the functionality and calculations used are provided below.

### Contributing Actions Table

- **4. Total Planned Contributing Expenditures (LCFF Funds)**
  - This amount is the total of the Planned Expenditures for Contributing Actions (LCFF Funds) column.
- **5. Total Planned Percentage of Improved Services**
  - This percentage is the total of the Planned Percentage of Improved Services column.
- **Planned Percentage to Increase or Improve Services for the coming school year (4 divided by 1, plus 5)**

- This percentage is calculated by dividing the Total Planned Contributing Expenditures (4) by the Projected LCFF Base Grant (1), converting the quotient to a percentage, and adding it to the Total Planned Percentage of Improved Services (5).

### **Contributing Actions Annual Update Table**

Pursuant to *EC* Section 42238.07(c)(2), if the Total Planned Contributing Expenditures (4) is less than the Estimated Actual LCFF Supplemental and Concentration Grants (6), the LEA is required to calculate the difference between the Total Planned Percentage of Improved Services (5) and the Total Estimated Actual Percentage of Improved Services (7).   - This amount is the Total Estimated Actual Expenditures for Contributing Actions (7) subtracted from the Total Planned Contributing Expenditures (4).
- **5. Total Planned Percentage of Improved Services (%)**
  - This amount is the total of the Planned Percentage of Improved Services column.
- **8. Total Estimated Actual Percentage of Improved Services (%)**
  - This amount is the total of the Estimated Actual Percentage of Improved Services column.
- **Difference Between Planned and Estimated Actual Percentage of Improved Services (Subtract 5 from 8)**
  - This amount is the Total Planned Percentage of Improved Services (5) subtracted from the Total Estimated Actual Percentage of Improved Services (8).

### **LCFF Carryover Table**

- **10. Total Percentage to Increase or Improve Services for the Current School Year (6 divided by 9 plus Carryover %)**

- This percentage is the Estimated Actual LCFF Supplemental and/or Concentration Grants (6) divided by the Estimated Actual LCFF Base Grant (9) plus the LCFF Carryover – Percentage from the prior year.
- **11. Estimated Actual Percentage of Increased or Improved Services (7 divided by 9, plus 8)**
  - This percentage is the Total Estimated Actual Expenditures for Contributing Actions (7) divided by the LCFF Funding (9), then converting the quotient to a percentage and adding the Total Estimated Actual Percentage of Improved Services (8).
- **12. LCFF Carryover — Dollar Amount LCFF Carryover (Subtract 11 from 10 and multiply by 9)**
  - If the Estimated Actual Percentage of Increased or Improved Services (11) is less than the Estimated Actual Percentage to Increase or Improve Services (10), the LEA is required to carry over LCFF funds.  
  
The amount of LCFF funds is calculated by subtracting the Estimated Actual Percentage to Increase or Improve Services (11) from the Estimated Actual Percentage of Increased or Improved Services (10) and then multiplying by the Estimated Actual LCFF Base Grant (9). This amount is the amount of LCFF funds that is required to be carried over to the coming year.
- **13. LCFF Carryover — Percentage (12 divided by 9)**
  - This percentage is the unmet portion of the Percentage to Increase or Improve Services that the LEA must carry over into the coming LCAP year. The percentage is calculated by dividing the LCFF Carryover (12) by the LCFF Funding (9).
